Introduction

Screening analysis for this Study consisted of a three-pronged, sequential approach. These three screening analyses, using industry best practices, were:

- Screening One – Operational Screening
- Screening Two – Comparison Study Area Analysis
- Screening Three – Comparison Concept Design Screening

The environmental screening was accomplished in Screening Two and Screening Three.

One of the criteria used for comparison of alternatives in Screenings Two and Three was Threatened and Endangered Species (T&E species). The U.S. Fish and Wildlife Service's (USFWS) Information for Planning and Consultation (IPaC) tool was used to compare the impacts of the proposed station and infrastructure alternatives on T&E species found to occur in the potential station areas. IPaC is a project planning tool allowing online exploration of T&E species and their potential habitat.

Appendix F provides the background IPaC data used in this analysis.

1 Overview of Study Areas

The Study developed potential station study areas in the New River Valley (NRV). Each area was screened through a process that examined impacts and identified the least impactful area. The examination of the railroad corridors and the locations described by previous studies resulted in five potential passenger rail station locations. The potential locations were determined by analyzing the track alignments and track grades for relatively straight, flat sections of the railroad corridors. Based on the factors described above, the five station locations considered in the Study are:

- North of NRV Mall (NRV-N)
- NRV Mall West (NRV-W)
- Ellett
- Merrimac
- North Franklin East

After Screening One – Operational Screening determined the operational feasibility at each location, the North Franklin East location was dismissed from further consideration. The four areas retained for Screening Two – Comparison Study Area Analysis are described in this section.

1.1 NRV Mall Study Areas

Alternatives near the NRV Mall are located along the Blacksburg Branch north and west of the Uptown Christiansburg mall on private property. Characteristics of the two sites are similar and may be considered as one alternative as the project moves forward.

1.1.1 NRV-N STUDY AREA

Located on the Blacksburg Branch, NRV-N is less than one mile from the Virginian Line along the Blacksburg Branch. NRV-N is proposed on private property east of the Blacksburg Branch due to the topography and location of a stream on the west side of the Blacksburg Branch at this location. The railroad is relatively straight through this area with a grade sloping down from south to north. A screening analysis resulted in a more constructible concept with fewer environmental impacts than the Merrimac and Ellett stations. The NRV-N area has similar environmental impacts as the NRV-W area.

1.1.2 NRV-W STUDY AREA

Located on the Blacksburg Branch, NRV-W is approximately one mile from the Virginian Line and is located adjacent to the Uptown Christiansburg mall. NRV-W is proposed on private property between the Huckleberry Trail, the Uptown Christiansburg Mall parking lot, and New River Road NW. The area lies east of the Blacksburg Branch due to the topography and location of a stream on the west side of the Blacksburg Branch. A screening analysis resulted in a more constructible concept with fewer environmental impacts than the Merrimac and Ellett stations. The NRV-W area has similar environmental impacts as the NRV-N area.

1.2 Ellett Study Area

Located on the Virginian Line, Ellett is more than two miles from US 460 Business. This is a critical distinction for this area. Ellett is proposed on private property south of the Virginian Line due to

the roads, topography, and location of a stream on the north side of the Virginian Line in this area. The railroad is relatively straight through this area with a grade sloping down from west to east. A screening analysis resulted in a constructible concept with more environmental impacts than the NRV-N and NRV-W areas.

1.3 Merrimac Study Area

Located on the Virginian Line, Merrimac is approximately one mile from US 460 Business. This is a critical distinction for this area. Merrimac is proposed on private property south of the Virginian Line due to the topography and location of a stream and steep terrain on the north side of the Virginian Line. The railroad is relatively straight through this area with a grade sloping down from east to west. A screening analysis resulted in a constructible concept with more environmental impacts than the NRV-N and NRV-W stations.

Environmental impacts within these study areas may be avoided, minimized, or mitigated. For additional information, the full screening analysis for these stations is available in **Appendix C**.

2 Intent, Methodology, and Comparative Analysis

The intent of the Study was to develop:

- A purpose and need for the NRV Station
- A technical feasibility analysis of locations for a passenger rail station in the NRV
- Complete technical work to obtain a National Environmental Policy Act (NEPA) Class of Action determination from the lead federal agency, most likely the Federal Railroad Administration (FRA)

The Study outlines the results of the screening analysis for station locations, areas, and alternatives. The results were presented to the public and stakeholders for input. The Study concluded with a NEPA Class of Action requested by the Virginia Passenger Rail Authority (VPRA) to the FRA.

The NEPA Class of Action was needed for VPRA to develop an environmental document to further assess and develop mitigation for an NRV Station alternative(s) identified in the Study. Subsequent NEPA work will include further engineering design related to a station alternative(s) and will identify, analyze, and mitigate potential impacts to the environment caused by an NRV passenger rail station.

After an initial assessment of operational feasibility, the environmental component of the Study involved a comparative analysis performed in two-phases. Screening Two used large study areas (**Figure 2.5** in the Feasibility Study) and included the proposed connector track for trains to access the NRV Mall sites and proposed roads for transit vehicles to access the Merrimac and Ellett sites in the analyzed IPaC report study areas. Screening Three was more focused on the concept design impact limits.

3 Assessment of Impacts to Species and Habitats in Study Areas

Threatened species and endangered species existed within the larger study areas and may be avoided, minimized, or mitigated by station design or construction scheduling. The environmental review (described in **Chapter 2.5** in the Feasibility Study) resulted in environmental findings that indicated that all four study areas had some potential for environmental impacts. The results also indicated that no study area had significant impacts that eliminated the study area from further consideration. The Study recognized that impacts to T&E species are avoidable by the location of the station within the study area and by the scheduling of construction activities. T&E species within the study areas are further discussed in this appendix.

3.1 Information for Planning and Consultation

The USFWS's IPaC tool was used to compare the impacts of the proposed station and infrastructure alternatives on T&E species found to occur in the study areas. Moreover, IPaC is a project planning tool allowing online exploration of T&E species and their potential habitat. IPaC also indicates listed species, critical habitat, migratory birds, or other natural resources that may be impacted by a project.

For this Study, T&E investigations were conducted at a high-level. This appendix provides a desktop analysis of the T&E species. T&E investigations did not conduct coordination with NEPA-level agencies or intensive field investigations. Such technical studies and reports, as well as coordination, will be performed during the NEPA environmental process. Migratory birds were excluded from the analysis due to their migratory nature without a fixed habitat. Migratory birds will be investigated further during the NEPA environmental process.

3.1.1 IDENTIFIED SPECIES

The resulting IPaC species list identified T&E species, proposed and candidate species, as well as proposed and final designated critical habitat that may occur within the boundary of the study areas. The IPaC species list meets the requirements of the USFWS under section 7(c) of the Endangered Species Act (ESA) of 1973, as amended (16 U.S.C. 1531 et seq.). A summary of the findings for the Ellett and Merrimac locations indicated that both locations have the possibility of T&E species as follows:

- Northern Long-Eared Bat (*Myotis septentrionalis*)
- Indiana Bat (*Myotis sodalis*)
- Smooth Coneflower (*Echinacea laevigata*)
- Monarch Butterfly (*Danaus plexippus*)

The NRV Mall have the same T&E resources as above with the exception of the Smooth Coneflower. Thus, the two NRV Mall alternatives have the potential for fewer T&E Species impacts.

3.1.2 CRITICAL HABITAT

Critical habitat is a habitat area essential to the conservation of a listed species, though the area need not actually be occupied by the species at the time it is designated. This is a specific term and designation within the ESA. Critical habitat must be designated for all threatened species and endangered species under the ESA, with certain specified exceptions. Designations of critical habitats must be based on the best scientific information available and in an open public process within specific timeframes. It applies only when federal funding, permits, or projects are involved.

For this Study, the intent was to identify if any critical habitat existed within any of the study areas, to identify where the habitat was located in a study area, to determine what quantity of habitat was impacted, and to use this data to rank the areas.

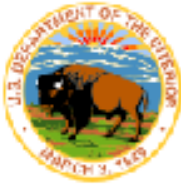
The Northern Long-eared Bat was listed as threatened and there was no critical habitat designated in the IPaC report. The Indiana Bat was listed as endangered and there was final critical habitat for the species, but the location of the critical habitat was unavailable from IPaC. The Smooth Coneflower was listed as endangered and there was no critical habitat designated. The Monarch Butterfly was considered a candidate species and there was no critical habitat designated.

There was no critical habitat in all four study areas. While there may be habitat where a particular species could live, there was no designated critical habitat present.

4 U.S. Fish and Wildlife Service Determinations

Pursuant to Section 7 of the ESA, USFWS provides an official species list determining whether any species which is listed or proposed to be listed may be present in the area of proposed action. A USFWS IPaC request was performed for the four study areas on March 22, 2022. The following are letters and attachments from USFWS detailing the T&E species, and proposed and candidate species, as well as proposed or final designated critical habitat, that may occur in the submitted study area and could be affected by proposed actions. All four study areas are referenced in the agency determinations below.

Any activity proposed on National Wildlife Refuge lands must undergo a 'Compatibility Determination' conducted by the Refuge. Please contact the individual Refuges to discuss any questions or concerns.

New information based on updated surveys, changes in the abundance and distribution of species, changed habitat conditions, or other factors could change this list. Please feel free to contact us if you need more current information or assistance regarding the potential impacts to federally proposed, listed, and candidate species and federally designated and proposed critical habitat. Please note that under 50 CFR 402.12(e) of the regulations implementing section 7 of the Act, the accuracy of this species list should be verified after 90 days. A Biological Assessment is required for construction projects (or other undertakings having similar physical impacts) that are major Federal actions significantly affecting the quality of the human environment as defined in the National Environmental Policy Act (42 U.S.C. 4332(2) (c)). For projects other than major construction activities, the Service suggests that a biological evaluation similar to a Biological Assessment be prepared to determine whether the project may affect listed or proposed species and/or designated or proposed critical habitat. Recommended contents of a Biological Assessment are described at 50 CFR 402.12.

If a Federal agency determines, based on the Biological Assessment or biological evaluation, that listed species and/or designated critical habitat may be affected by the proposed project, the agency is required to consult with the Service pursuant to 50 CFR 402. In addition, the Service recommends that candidate species, proposed species and proposed critical habitat be addressed within the consultation. 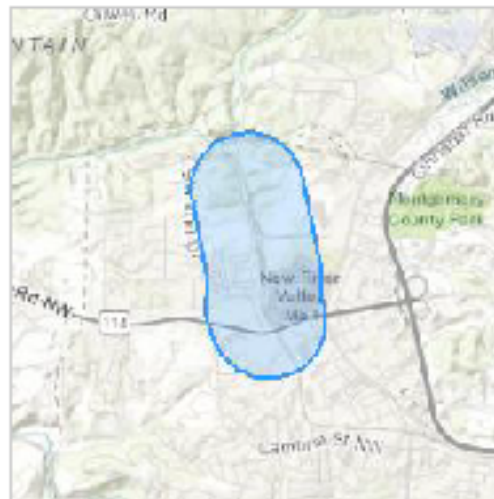

One can have higher confidence in the presence score if the corresponding survey effort is also high.

How is the probability of presence score calculated? The calculation is done in three steps:

1. The probability of presence for each week is calculated as the number of survey events in the week where the species was detected divided by the total number of survey events for that week. For example, if in week 12 there were 20 survey events and the Spotted Towhee

was found in 5 of them, the probability of presence of the Spotted Towhee in week 12 is 0.25.

2. To properly present the pattern of presence across the year, the relative probability of presence is calculated. This is the probability of presence divided by the maximum probability of presence across all weeks. For example, imagine the probability of presence in week 20 for the Spotted Towhee is 0.05, and that the probability of presence at week 12 (0.25) is the maximum of any week of the year. The relative probability of presence on week 12 is $0.25/0.25 = 1$; at week 20 it is $0.05/0.25 = 0.2$.
3. The relative probability of presence calculated in the previous step undergoes a statistical conversion so that all possible values fall between 0 and 10, inclusive. This is the probability of presence score.

Breeding Season (■)

Yellow bars denote a very liberal estimate of the time-frame inside which the bird breeds across its entire range. If there are no yellow bars shown for a bird, it does not breed in your project area.

Survey Effort (|)

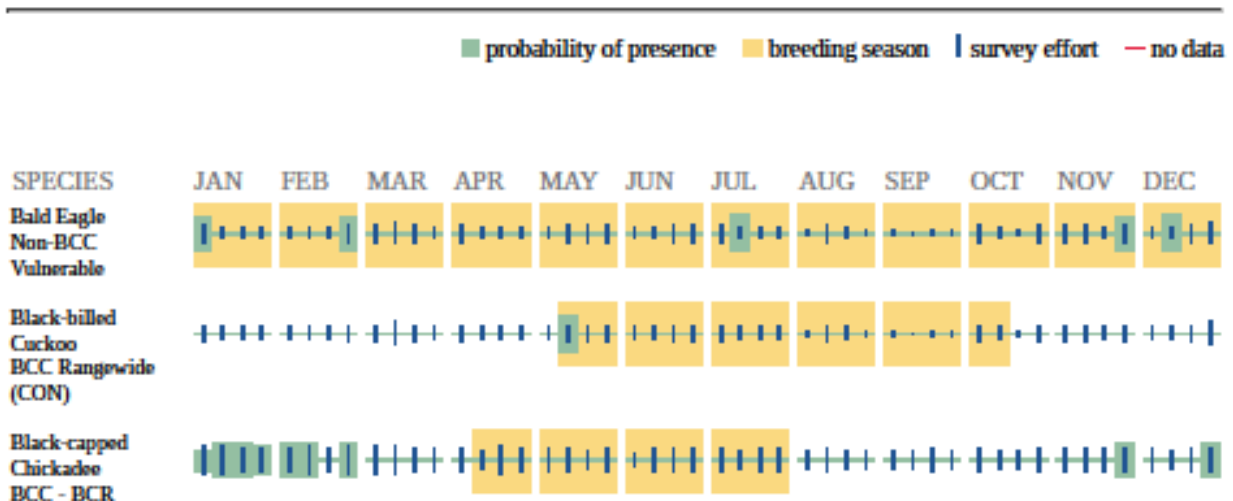

A week is marked as having no data if there were no survey events for that week.

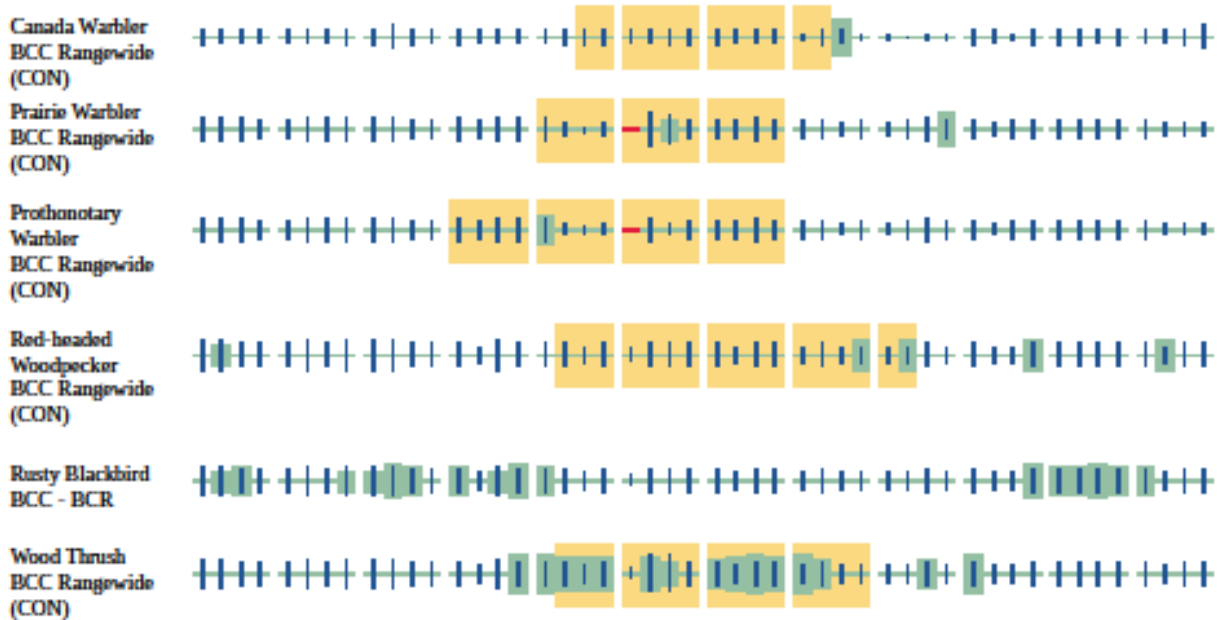
Survey Timeframe

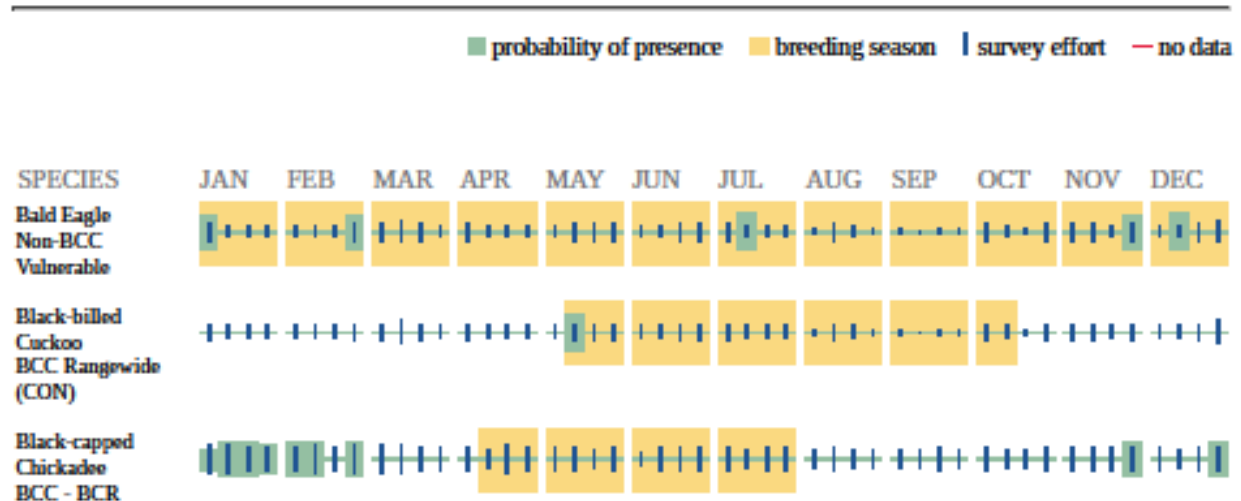

The U.S. Fish and Wildlife Service (Service) received on March 22, 2022 your effects determination for the 'New River Valley-Mall Location' (the Action) using the northern long-eared bat (*Myotis septentrionalis*) key within the Information for Planning and Consultation (IPaC) system. This IPaC key assists users in determining whether a Federal action is consistent with the activities analyzed in the Service's January 5, 2016, Programmatic Biological Opinion (PBO). The PBO addresses activities excepted from "take"^[1] prohibitions applicable to the northern long-eared bat under the Endangered Species Act of 1973 (ESA) (87 Stat.884, as amended; 16 U.S.C. 1531 et seq.).

Based upon your IPaC submission, the Action is consistent with activities analyzed in the PBO. The Action may affect the northern long-eared bat; however, any take that may occur as a result of the Action is not prohibited under the ESA Section 4(d) rule adopted for this species at 50 CFR §17.40(o). Unless the Service advises you within 30 days of the date of this letter that your IPaC-assisted determination was incorrect, this letter verifies that the PBO satisfies and concludes your responsibilities for this Action under ESA Section 7(a)(2) with respect to the northern long-eared bat.

Please report to our office any changes to the information about the Action that you submitted in IPaC, the results of any bat surveys conducted in the Action area, and any dead, injured, or sick northern long-eared bats that are found during Action implementation. If the Action is not completed within one year of the date of this letter, you must update and resubmit the information required in the IPaC key.

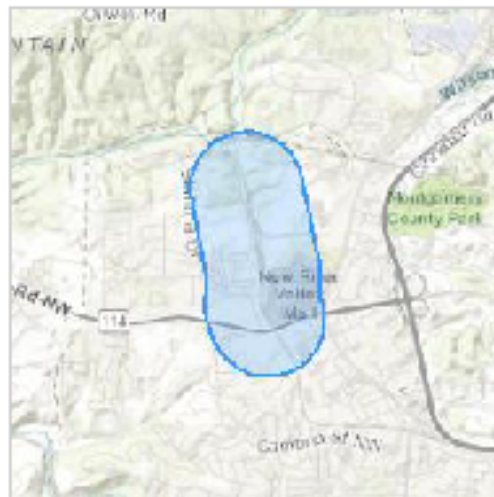

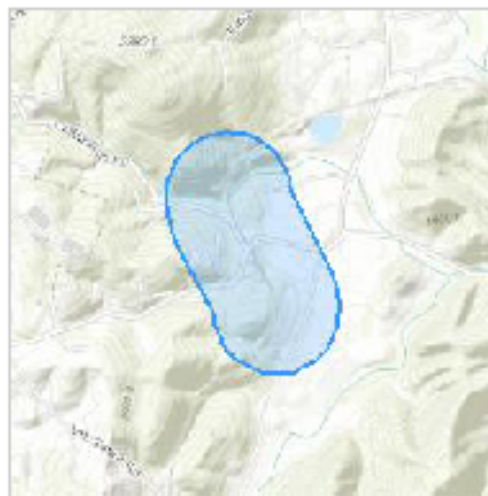

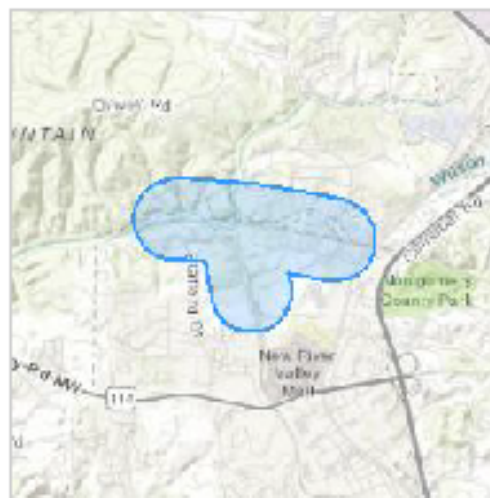
