## **CALL TO ORDER/ROLL CALL**

Chairperson DeBruhl presided and called the meeting to order at 10:00 a.m. Ms. Douglas called roll and confirmed a quorum was present.

# **MOTION TO APPROVE PREVIOUS MEETING MINUTES**

A motion was made by Sharon Bulova and seconded by Patricia Doersch to approve the previous board meeting minutes. The motion was carried unanimously, with the vote in favor cast by Sharon Bulova, Deb Butler Painter, Victor Cardwell, Patricia Doersch, Jay Fisette, Cynthia Moses-Nedd, and Jim Spore.

#### **EXECUTIVE DIRECTOR'S REPORT**

Presented by: DJ Stadtler, Executive Director, Virginia Passenger Rail Authority

Mr. Stadtler presented the Executive Director's report to brief the board about administrative updates,

Amtrak performance data, capital project updates, and financial updates for the previous month.

Mr. Fisette asked about train frequency and reliability and noted that due to these concerns many people don't take the train. He asked what we can to do increase metrics for on-time performance. Discussion was held regarding the shared track with freight and its impact on schedules as well as other schedule concerns. Mr. Fisette asked for more information regarding work being done to pinpoint a consistent pattern of problems regarding this matter.

Joan Panik reviewed updates from a staffing perspective. Work has been done regarding VPRA's Mission, Vision, and Values. Ms. Doersch noted that VPRA is not a typical state agency. She asked what the process was that VPRA followed when coming up with the Mission, Vision, and Values. Ms. Panik noted that it was an all-authority collaboration and came from the employees. Mr. Fisette pointed out that teamwork and culture are important to how VPRA establishes itself. Ms. Bulova noted that she feels this is great work and that it shows ownership by the employees.

Mike McLaughlin provided an update on capital projects. All numbers presented are within scope for the budget of the project.

Steve Pittard reviewed financial updates for the month of April. Expenditure activity has been picking up as projects get up and running. Cost recovery percentages are at 81% compared to budget of 73%.

#### **FY23 VPRA BUDGET**

Steve Pittard reviewed the FY23 budget. He noted that CTB had approved the Capital Projects portion of the VPRA FY23 Budget on April 19, 2022. Ms. Butler Painter asked if there had been any developments on the supply chain side that would make it challenging to spend the money. Mr. Pittard noted that he did not anticipate any issues. Ms. Butler Painter noted that

she appreciates the effort not to come back for amended budgets.

#### MOTION TO APPROVE THE RECOMMENDED FY23 VPRA BUDGET

A motion was made by Sharon Bulova and seconded by Rod Hall to approve the FY23 VPRA Budget. The motion was carried unanimously with the vote in favor cast by Sharon Bulova, Deb Butler Painter, Victor Cardwell, Patty Doersch, Jay Fisette, Rod Hall, Cynthia Moses-Nedd, Paul Nichols, and Jim Spore.

#### **FINANCIAL PLAN**

Presented by: Steve Pittard, Virginia Passenger Rail Authority, and KPMG Consultants

KPMG has been working with VPRA to create a financial plan, based on what we know now, that gives more information on the funding plan for the capital projects. VPRA is actively looking forward to funding opportunities as progress is made through the phases of the projects. Ms. Doersch asked how we budget for the potential to get federal funds? Mr. Pittard noted that until the funds are awarded, he will not put them in the budget. VPRA has applied for federal funds to cover the following projects: New River Valley, Long Bridge Pedestrian and Bike bridge, and Newport News. Ms. Doersch asked what the money could be spent now, and Mr. McLaughlin noted it could be spent on design. Ms. Butler Painter complimented the group on the risk management part of the financial plan and asked how often the Board would be updated as the risk management portfolio evolves. Mr. Stadtler notes that the Board will be updated on a regular basis.

# **VPRA HR MANUAL**

Joan Panik reviewed the updated VPRA HR manual and highlighted changes. The initial review of the Employee Manual was in February 2021. There are 11 new policies, 24 updated policies, two deleted policies, and no substantive changes for 32 policies. Mr. Fisette asked about the status of aligning our policies with the Commonwealth. The intent is to remain as consistent as possible. Mr. Westermann notes that VPRA has some flexibility but closely aligns with the Commonwealth. Mr. Fisette agreed that it is good to align where possible and where there is no substantive reason to vary. Ms. Bulova asked about the Public Health Emergency leave and how it was updated to reflect the Governor's most recent update. Ms. Panik noted that those are items like mask mandates. Mr. Stadtler notes that VPRA does its best to attract quality employees. We complete risk management reviews monthly.

## **MOTION FOR CLOSED SESSION**

- b. Section 2.2-3711 (A)(8) of the Code of Virginia, for the purpose of consulting with legal counsel regarding the legal effect of proposed VPRA Procurement Rules.

"Additionally, I move that:

- a. For the purposes of the motion based on Section 2.2-3711 (A)(1) of the Code of Virginia, legal counsel and the VPRA chief Administrative Officer attend the Closed Session, and
- b. For the purposes of the motion based on Section 2.2-3711 (A)(8) of the Code of Virginia, staff and legal counsel attend the Closed Session,

because, in each case, their presence is deemed necessary and will aid the board in its consideration of these matters."

The motion was seconded by Jay Fisette and carried unanimously with the vote in favor by Sharon Bulova, Deb Butler Painter, Victor Cardwell, Patricia Doersch, Jay Fisette, Rod Hall, and Cynthia Moses-Nedd, and Jim Spore.

The Board suspended the open session at 11:30 a.m. on May 23, 2022, to move into a closed session.

# **RECONVENE IN AN OPEN SESSION**
