CALL TO ORDER/ROLL CALL

Chairperson DeBruhl presided and called the meeting to order at 10:01 a.m. Ms. Douglas called roll and confirmed a quorum was virtually present.

BOARD CHAIR WELCOME

MOTION FOR CLOSED SESSION

Sharon Bulova made the following motion:

"I move that the Board convene in a Closed Session pursuant to Section 2.2-3711 (A)(6) of the Code of Virginia, for the discussion or consideration of the investment of public funds where competition or bargaining is involved, where, if made public initially, the financial interest of VPRA would be adversely affected.

A motion was made by Sharon Bulova and seconded by Victor Cardwell to move into a closed session. The motion was carried unanimously, with the vote in favor cast by Sharon Bulova, Sandy Bushue, Victor Cardwell, Patricia Doersch, Rod Hall, Cynthia Moses-Nedd, Beth Rhinehart, and John Watkins.

The Board moved into closed session at 10:04 a.m. on November 16, 2023.

RECONVENE IN AN OPEN SESSION

The chairperson reconvened the open session meeting at 11:55 a.m. on November 16, 2023. Upon reconvening the meeting, the vice-chairperson made the following statement:

"We are now going to take a roll call vote, and I ask that each member indicate their agreement with the following:

To the best of my knowledge, during the Closed Meeting, the only matters heard, discussed, or considered were those matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act, and only those public business matters as were identified in the motion by which the Closed Meeting was convened."
