CALL TO ORDER/ROLL CALL

Chairperson Patricia Doersch presided and called the meeting to order at 10:45 a.m. Mary Estelle Douglas called roll and confirmed an in-person quorum was present.

MOTION FOR CLOSED SESSION

John Delandro made the following motion:

• "I move that the Board convene in a Closed Session:

(i) pursuant to Va. Code Sec. 2.2-3711(A)(29) for the discussion of public contracts relating to VPRA's Transforming Rail in Virginia projects involving the expenditure of public funds, including discussion of the terms or scope of such contracts, where discussion in an open session would adversely affect the bargaining position and negotiating strategy of VPRA.

The motion was seconded by John Watkins and carried unanimously with the vote in favor by Patricia Doersch, John Delandro, Thelma Drake, Tiffany Robinson, Darien Flowers, and John Watkins.

RECONVENE IN AN OPEN SESSION

The Chairperson reconvened the open session. Upon reconvening the meeting, John Delandro made the following statement:

"We are now going to take a roll call vote, and I ask that each member indicate their agreement with the following:

To the best of my knowledge, during the Closed Meeting, the only matters heard, discussed, or considered were those matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act, and only those public business matters as were identified in the motion by which the Closed Meeting was convened."

The roll was then called, and all members indicated their agreement with the statement. Patricia Doersch, John Delandro, Thelma Drake, Darien Flowers, D.J. Jordan, Cynthia Moses-Nedd, Tiffany Robinson, and John Watkins indicated agreement.
